Notification

- g) All terms and conditions of Public Administration Training and Higher Education Policy, 2023 and other related Rules and Regulations for training/studying abroad will be applicable;
- h) The provision of Rule 34 of Appendix VIII of BSR (Part-1) is applicable for this approval.
