

Furnish Performance Securities in the form as specified and in the amount of i) **Tk 1,75,000/=** (One Lac Seventy Five Thousand Taka only) for **Lot-02**, ii) **Tk 1,25,000/=** (One Lac Twenty Five Thousand Taka only) for **Lot-03**, and iii) **Tk 1,25,000/=** (One Lac Twenty Five Thousand Taka only) for **Lot-04** within fourteen (14) days of acceptance of this LOA but not later than 29 January 2020, in accordance with ITT Clause 51 and 52.
- iii. Sign the Contract within twenty eight (28) days of issuance of this LOA but not later than 11 February 2020, in accordance with ITT Clause 49 and 55.

You may proceed with the execution of the said Contract for the provision of Services in accordance with the Contract documents only upon completion of the above tasks. You may also please note that this Letter of Acceptance shall constitute the formation of this Contract which shall become binding upon you.
